The Postal Ballot / E-voting process commenced from Monday, May 30, 2016 at 9.00 a.m. and ended on Tuesday, June 28, 2016 at 5.00 p.m.

Mrs. Vinita Nair, Partner of M/s. Vinod Kothari & Co., Company Secretaries, who was appointed as Scrutiniser to scrutinise and report on Postal Ballot / E-voting by shareholders on the said resolution, has issued report dated June 30, 2016 and based on the said Scrutiniser's report, the Executive Director & CEO of the Company has today i.e. on June 30, 2016, declared that the **Ordinary Resolution**, proposed in the Postal Ballot Notice dated May 18, 2016, has been approved by unrelated shareholders with requisite majority (with 99.84% voting in favour of resolution and 0.16% voting against the resolution) and therefore the said Ordinary Resolution is deemed to be passed on June 28, 2016 (Last date of voting by Postal Ballot / E-voting).

In keeping with the requirements of the Rules, 2014, we submit our report as under:

- 1. As per the information provided to us, the Company had completed the despatch of postal ballot notice, along with the postal ballot form and business reply envelope (postage prepaid) on May 30, 2016by courier and all the notices under electronic mode were also sent on the same day to all such members whose names appeared on the Register of Members/list of beneficiaries as at close of business on Friday, May 20, 2016.
- The e-voting period commenced from Monday, May 30, 2016 at 9.00 a.m. and ended on Tuesday, June 28, 2016 at 5.00 p.m. The NSDL e-voting platform was blocked thereafter and the votes cast under e-voting facility were then unblocked by us in the presence of two witnesses who were not in the employment of the Company. Votes cast through physical ballots were considered till June 28, 2016.
- Public Notice containing relevant details as required by Rules, 2014 was published in English Newspaper 'dna' on May 30, 2016 and in Marathi Newspaper Navshakti on June 01, 2016.
